Govt reduces 'dry days' to just 3, industry cheers move

LIQUOR SHOPS across the capital will be closed on Republic Day, Independence Day and Gandhi Jayanti this year, with Delhi government reducing the number of 'dry days' from 21 to just three.

The changes in the number of 'dry days' were made under the new excise policy, with the official notification being issued on Monday. Delhi used to observe the largest number of 'dry days' as compared to any other state.

"In pursuance of the provisions of Rule 52 of Delhi Excise Rules, 2010, it is hereby ordered that the following dates shall be observed as 'Dry Day' in the National Capital Territory of Delhi by all licensees of the Excise department and opium vends located in Delhi for the year 2022 – Republic Day, Independence Day and Gandhi Jayanti. Apart from the above three dry days, the government may declare any other day in the year as 'dry day' from

The decision was welcomed by the hospitality industry in Delhi. "This move will benefit both consumers as well as traders. It will save us from losses that earlier occurred due to more 'dry days' that meant closure of shops and restaurants and business despite paying full licence fee for the year," said Kabir Suri, president of National Restaurants Association of India. Meanwhile, the BJP, which

had staged a chakka jam against the new excise policy earlier this month, called the move a 'political stunt' and said they will protest if any new liquor shop is opened in Delhi. Leader of Opposition in Delhi Assembly, Ramvir Singh Bidhuri, said, "There were about 500 active liquor vends and now it has gone up to 850, which makes the intention of the state government clear - to make Delhi a city of liquor. Earlier, these shops used to remain open till 11 pm; now, they will be open till 3 am. In such an atmosphere, one cannot think of a peaceful society."

He appealed to residents to inform the party if new liquor shop opens in their area, and said BJF MLAs will go there and oppose it: "We will force the state government to withdraw its new excise policy. Earlier, there used to be 'dry days' on birth anniversaries of great leaders. Now, there will be only three dry days, which shows that the government can go to any extent to increase its revenue."

Court frames sedition charges against Sharjeel over Jamia speech

A DELHI court Monday framed charges against INU student Sharjeel Imam for allegedly making inflammatory speeches at Aligarh Muslim University and in Delhi's Jamia area against the Citizenship Amendment Act (CAA), based on an FIR filed on January 25, 2020.

was argued by his lawyer, Tanvir Ahmed Mir. The prosecution, during arguments, told the court that his speeches give a clear indication that Muslims have no hope and his alleged call to burn detention camps was not peaceful. Imam's lawyers had submitted that without criticism, a society dies and becomes a heap of sheep.Mir argued that there was nothing in the impugned speech made by Imam that "directly or

indirectly calls for violence". The 2020 FIR, filed at the Crime Branch police station, was in connection with speeches December 13, 2019. The Delhi Police Crime Branch has accused him of giving "inflammatory and instigatory speeches against the Government of India on the issue of CAA and NRC".

"He, through his speeches, repeatedly incited the public to commit acts which would jeopardise public tranquillity, attempts to cause disaffection towards lawfully government of the country in the garb of democratically opposing the CAA. His oration and acts are seditious in nature," states the chargesheet.

Is this really the endgame? Is Omicron likely to be the last major variant of this coronavirus? Is it possible to predict how the virus would mutate in future? Dr. do we need to reconcile ourselves to living with periodic, but regular, waves of infection in future? Is there anything we can do to prevent future waves? Or, are we helpless?

These, and many such, questions are the uppermost on the minds of everyone as India negotiates its third wave of infections. There are few people in the country who understand these questions better than Dr. Anurag Agrayal, director of Delhi-based Institute of Genomics and Integrative Biology, a CSIR research laboratory. As head of an institution that is currently involved in generating scientific information required to prepare response measures for the pandemic, Dr. Agrawal is one of the key voices in the government's decision-making apparatus
